

AASTMT Sustainable Construction and Biodiversity Support Report – 2025

This report outlines AASTMT's engineering approach to constructing, operating, and maintaining buildings according to sustainability standards across all campuses. It highlights the use of passive design strategies, renewable energy systems, water-saving technologies, and energy-efficient HVAC and lighting. The document also showcases actions to reduce heat islands, improve natural ventilation, and expand green landscapes using native vegetation. Sustainable site management practices—such as groundwater use, rainwater infiltration, recycling, and waste reduction—are emphasized. The report includes documented projects (2015–2025) showing the application of these sustainability criteria in real AASTMT facilities.
