




The GSB at The Arab Academy for Science, Technology and Maritime Transport, hereafter referred to as AAST and Children's Cancer Hospital Foundation Egypt, hereinafter referred to as CCHF, considering their common interests in promoting mutual cooperation in the areas of education and research, both parties, therefore, wish to formalize their partnership for collaboration and cooperation, and have set forth the following Memorandum of Understanding (MOU).

I: Purpose

The purpose of this MOU is to develop academic and educational cooperation on the basis of equality and reciprocity, and to promote relations and mutual understanding between the two institutes.

II: Scope of the Cooperation

Both parties agree:


1. To collaborate and integrate resources and capabilities to innovate for impact in terms of Education providing **MBA in Hospital Management**.
2. To promote reciprocal exchange of expertise to enhance transformational learning and practical approaches for supporting the forging of change agents to benefit the Egyptian job market & human resource;
3. To promote national and international research activities of both faculty and students, as well as staff researchers and enhance application of research;
4. To foster collaboration and exchange of academic publications and information;
5. To promote various collaboration on third-party funded educational, entrepreneurial, extra-curricular and research activities; and
6. To promote other academic activities including but not limited to: dual-degree programs, team or joint teaching, training and development of staff and students, financial arrangements for students, international conferences, symposia, seminars and guest speakers.

III: Financial Arrangement


1. Both parties agree that all specific arrangements and plans for activities are to be negotiated, and are dependent on availability of funds;
2. Both parties agree to seek financial support from national and international organizations for the cooperative to be activities to be undertaken as stated under the name of this MOU.

IV: Agreement of Implementation

1. This institutional level general MOU is designed to facilitate development of mutually beneficial exchanges/programs and to promote research, entrepreneurial and educational relationships, and should not be deemed to create legal and financial obligations between the parties;
2. Before any of the initiatives may be implemented, both parties shall negotiate detailed terms and conditions and resolve issues involved therewith, and enter into an agreement pertaining to that activity (Specific Cooperative Agreement", "SCA"). Each such Specific Cooperative Agreement shall be subject to the availability of any resources required for the initiative;
3. Any Specific Cooperative Agreement (SCA) shall include such items as:
 - A brief description of rationale and value of the initiative/program for both parties
 - Detailed terms and conditions involved
 - Elaboration of responsibilities of each institution for the agreed upon terms
 - Schedules for specific activities
 - Budgets and sources of financing for each activity
 - Any other items deemed necessary for efficient management

V: Settlement of Differences

The differing viewpoints and interpretations of this MOU shall be settled amicably by mutual consultation or negotiation.

VI: Amendments, Duration and Termination

1. Amendments to this MOU can only be written by mutual consent for the two parties;
2. This MOU shall be in effect from the date of its signing and be valid for the duration of five (5) years from that date, and will be automatically renewed on an annual basis thereafter, unless terminated or replaced with a new MOU;
3. This MOU may be terminated by either party by written notice at least six (6) months in advance. Such notice of termination will not interface with cooperative programs currently underway. Such programs will be allowed to continue until their conclusion.

VII: Administrative Supervision and Facilitation of the Partnership

1. Under the current MOU, all initiatives between the two institutions shall be appropriately facilitated and guided by each institution's official protocol for educational affairs;
2. For administrative supervision and facilitation of the MOU, [Title] [Name & Email] at CCHF AND [Title] [Name & Email] at AAST will coordinate official protocols.
3. Either party may change its own designated liaison by sending written notice to the other party of such change.
