MAIA-TAQA addresses the issue of the demand for efficiency services of renewable energy resources in the Southern Mediterranean area countries in order to hold the pressure on the environment and strengthen the energy supply.

- Steering committee member and coordinator (2015 September 2016): "Gameeti project", a franchise project offering commodity loans for more than 14000 young people ranging between EGP 50,000 to 100,000 each for the establishment of retail outlets supervised through a franchise right by the Holding Company for food Industries to increase the accessibility and the availability of commodities and food outlets to citizens and provide job opportunities for young people. 2000 outlets have been opened so far (creating 8000 direct jobs), presenting by this the largest chain in the Middle East in terms of the number of outlets.

  - "Egypt's Food Industries, consumer complexes e-linking project", in cooperation with Microsoft- this project connects Egyptian Food Industries Holding Company, groceries, wholesale companies and consumer complex companies in a unified electronic network as the biggest e-linking project in the Middle East. The project connects 500 wholesale ports with 40,000 retail outlets and groceries that serve all the suppliers to decrease the cost of goods traded in stores and consumer complexes by 30%, provide time-saving mechanisms in transportation and handling processes, as well as provide electronic reports on works in progress can be sent instantaneously in addition to information about consumer feedback and their requests or suggestions for the available commodities which allow creating an expert system to support strategic decisions.
- Participated in designing the logistics and the financial systems of the **Egyptian food subsidy system** (2014- September 2016).
  - The New Food Subsidy System includes (bread system, ration food system, new incentive points system). The new bread system improved the subsidized bread supply chain through shifting towards the output-based financing. On the Ration food system, the system has also moved from subsidized commodities to subsidized beneficiaries. The new system of food subsidy adopts an incentive points-based mechanism with a better consolidation of the two food subsidy programs. The unused monthly allowance of subsidized Bread converts into points, which could be used to buy other food commodities within the same Smart Card System. It worth mentioning that millions of Egyptians have suffered through long decades since 1970s from bread crisis and difficulty of obtaining it in addition to very bad quality.
- The Coordinator and The Manager of Financial Affairs (2012-2015): LACTIMED Project launched and financed by EU under Euro-Mediterranean Cooperation Agreement. The project aims to foster the production and distribution of typical and innovative dairy products in the Mediterranean by organizing local value chains, supporting producers in their development projects and creating new markets for their products. In the end, it will lead to the creation of the Mediterranean network of dairy clusters.
- **Designed the reward systems** for five main companies in the Egyptian food retail sector (2014 -2015).
